YOUR MEDICAL RECORD AND ENHANCED DATA SHARING WITH OTHER HEALTH PROFESSIONALS PROVIDING CARE TO YOU:

Today, electronic records are kept in all the places where you receive healthcare. These NHS Care Services can usually only share information from your records by letter email, fax or phone. At times, this can slow down your treatment and mean information is hard to access.

Your GP practice uses a computer system called SystmOne that allows the sharing of full electronic records across different NHS Care Services. We are telling you about this as a patient at this practice as you have a choice to make about how your practice shares information about your care from your electronic patient record. You can choose to share or not to share your electronic GP record with other NHS Care Services.

WHAT:

Our system is now set up to enable us, with your permission, to share your full record with other healthcare services who provide care for you and who use the same electronic record system that we do. This may include services such as the District Nurse, Smoking Cessation Service, Consultant at the hospital, Dietician, Specialist Heart Failure Nurses, the Hospice etc.

If you allow your GP practice to make your medical record "sharable" these other services will ask your permission to view your record and you can decide on a service by service basis who you wish to grant access to, i.e. you may wish to give access to the District Nurse who is providing you with care services but not to the podiatrist who may also be providing you with services. What you grant access to for one service is independent to the access given to other services.

BENEFITS:

Patient care can be supported by healthcare staff having faster access to your medical information and you may not be required to repeat information to different NHS staff treating you. For example, healthcare staff who are involved in your care will be able to access your medical history immediately, enabling them to assess the provision of your care better.

HOW:

- 1. If you decide that you would like it made possible to share your record in this way please let a member of staff at reception know or inform a clinician when you are in consultation. Alternatively, complete the reverse of this section of the leaflet and hand into reception.
- 2. If you are a new patient to us please indicate your preference in this regard on the "new patient questionnaire" that you will complete before registering with us.
- 3. In writing to the practice administration signed and dated
- 4. When a clinician makes a referral to a service on your behalf they may ask you whether you consent to sharing your record if they feel appropriate.
